The Trustees took the decision in 2007 that following the success of the educational support for the previous Carmen Presentee, Sam Carlyle, it was time to support another pupil. In May 2008 the selection began, with the criteria of London residency, low household income, good academic record at primary school, either from a one or two parent family which would be supportive despite family or social problems, five candidates and their mother or father were invited to attend an interview at the Carmen office.

All were worthy of consideration but with only one place available the recommendation was

made in favour of a cheerful young lady, an only child from a one parent family, who presented herself as quietly confident, intelligent, well motivated with wide interests and ability in gymnastics, music and languages – **Kemi.**

The recommendation met with the universal approval of all the Trustees at the July 2008 Trustee meeting and, thanks to Carmen generosity, your Trust has been privileged to continue its 500 year history of support for Christ's Hospital by funding Kemi's education for the next seven years.



## THE CARMEN'S BENEVOLENT TRUST, YOUR CHARITY, HELPING CHILDREN

Your Trust works with many charities involved with disadvantaged, sick or dying children. Some of the case work we read about is truly heart-rending but, it's always rewarding to hear that we REALLY do seem to make a difference with a little – where a little means a lot! Here are just a few extracts from 'thank you' letters with a brief explanation of the work of those charities.

## **CHICKS**

'Your wonderful donation of £1,000 was used to fund places for 2 very vulnerable children to have a much needed break away from it all in 2009.'

Country Holidays for Inner City Kids(CHICKS) has provided respite care for more than 5,000 people in London and the rest of the United Kingdom, reaching the most vulnerable and



disadvantaged children; victims of abuse and crime; children of addicts; those suffering extreme poverty, illness or bereavement and child carers.

## **MUDCHUTE**

'We are absolutely delighted with The Carmen's Benevolent Trust's decision to support our work with a cheque for £500. Your donation will enable us to buy much needed equipment for our main office which supports all the various services and facilities we provide'

Mudchute is situated on the edge of the City in Tower Hamlets, one of the most deprived places in the country, with one of the poorest child populations. The Mudchute is a designated nature reserve of some 33 acres with wild flora, wood-



land and grassland grazed on by the animals

on the farm. Here, City children learn of the wonder and beauty of the natural world and its wild life, the care of the animals and a range of skills which will enrich their lives forever. The contrast this setting makes to their normal life environment is very often life changing. We have mentioned this charity before but, we felt it worth a further exposure at this time.

## **REACT**

'We were delighted to receive your cheque for £1,155 to support another 3 terminally ill children and their families. We would convey our sincerest thanks to the Carmen's Benevolent Trust for this generous gift'

React is a charity providing equipment and support for terminally ill children. They are able to provide assistance 52 weeks a year and often at very short no-



tice. They work very closely with medical teams and carers to ensure that the equipment provided is tailored to the individual child's needs, short though they may often be.

## **PERTHES ASSOCIATION**

'Thank you so much for your recent donation of £800 which will enable us to buy a special trike for a disabled child'

The Perthes Association is a national charity and currently helps 1,200 families with children who suffer from severe hip bone conditions, the most common of which is Perthes disease. This disease usually affects children between 4 and 8 years old. The active stage of the disease lasts several years and medical treatment is essential to prevent permanent hip



deformity. Children very often need major surgery and this period in their lives is traumatic, not only for the children themselves, but, also, for their families.

## **DREAM HOLIDAYS**

'Thank you for your £1,000 donation. This will be put to immediate and important use. We recently received a letter from one of the families we support and thought that would like to read the following extract - sadly we lost our daughter last year, aged 16. She fought bravely to be strong enough to get on the transplant list but she was dogged by recurring chest infections and eventually died. She had a great time when you made it possible for us all to go to Oasis in 2001 and we have a lot of photos and happy memories of that holiday. Thank you for the special way you help kids with CF'

Dream Holidays is a charity granting breaks, holidays and wishes for children with cystic fibrosis. Their specialist em-



ployees and volunteers are able to deal with emergencies or complications which can occur in

this dreadful illness. They have a family hospital in Mytchett, near Camberley but operate up and down the land.

This short selection of thank you letters in connection with just a few of the children's charities we support will, hopefully, give you an insight into one important area of giving for the trust. Wherever possible, we look for a livery, city or transport link but are not restricted in dealing with very deserving cases.

## **HOW YOU CAN HELP**

As can be seen from the abstract of the accounts, donations, either regular or one off, are a vital source of your charity's income; all, large or small, are welcome and needed. There are many ways you can help:

- <u>Gift Aid Donations</u> tax efficient and an important part of our income stream. (For every £100 you give, your charity receives an additional £28 from the Government, until 2011 when it drops to £25 higher rate tax payers can also claim further benefits.)
- **Give as you Earn or Payroll giving** also tax efficient with simple administration as neither the Charity nor the individual needs to reclaim the tax. (Any money you donate from this scheme is deducted from your gross pay before tax i.e. a donation of £100 would only cost a higher rate taxpayer £60.) A further advantage for your charity is that some companies operating this scheme will match your contribution.
- Wills and Legacies Your charity also encourages members and others to nominate it in their Wills. Again, this legacy can be highly tax efficient for the donor.
